GOOD NEWS. Following on from the recent arson attacks in Coronation Woods the Police have identified several persons involved who will be dealt with in an anti-social behavioural format in conjunction with the anti-social behaviour team at ELDC.

Our local policing team are urging everyone to ensure all incidents are reported to them in the first instance to ensure they can deal efficiently and effectively with all complaints. It may seem trivial or not worth it but often the smallest detail can help build a bigger picture.

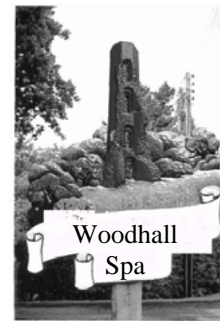

## JUBILEE PARK PROJECT- run by the community- for the community!

From the packed public meeting last month it's clear how much you all love our Park and want to ensure its long term future. For those of you who were not able to make it, here are the basic facts:

- We are proposing that the community takes over the running of Jubilee Park from the end of next season – with ELDC support- as a commercial venture to ensure its long term future
- A steering group, including volunteers with the necessary legal and business expertise supported by a number of consultants, has been set up to oversee the transition to a full established community-based and owned business organisation to take the Park forward
- Key items of the steering group work are the production of the business plan and the setting up of a suitable legal framework to run the Park in the long term
- The Project depends on the development of a viable and sustainable business plan which the steering aim to complete by next summer
- It will be essential to ensure that the assets of the Park (ie the pool, land and buildings etc) are protected to prevent them being sold off or otherwise misused in future; this protection will be written into the new company's Articles and Constitution.
- Financial cuts and changing ELDC priorities mean we will not be getting the entire £1.54m investment we had hoped for *but* we will be working with ELDC to determine the minimum level of investment that will make the pool sustainable and can be accommodated within the available funding.
- Staying as is, is not an option. ELDC is looking to cut its losses on facilities like this and is investigating putting them out to tender anyway.
- The steering group will report back to the Parish Council monthly and to the community through the village web site; we also anticipate holding further public meetings to gain support for the business plan assumptions and objectives as well as the composition of the legal/commercial organisation
- In the meantime we have already started working with ELDC on plans for next season- thank you for your many ideas on improving the running, marketing and promotion of the park. We still need them please. We want to start putting them into practice in 2010 so that hopefully we will already be seeing the benefit of improvements if all goes well and we take over a year from now.

Your thoughts are needed on ALL aspects of the running of the park and pool – opening hours (eg fulltime pool opening in June? ?), timings (do they sit you?), maintenance, alternative energy sources (solar, ground source heating?), pricing (how do we compare), publicity (what publicity?), extra attractions (cycle hire? gym? bistro?), new user groups (out of area swimming clubs? summer outings for county schools? etc) . As it's the pool that will be the biggest cost, we specially want to hear your experiences of successful ideas from other open air pools . Send them to the special email address [jubileeparkgroup@tiscali.co.uk](mailto:jubileeparkgroup@tiscali.co.uk), or via the existing community website [www.woodhallspa.org](http://www.woodhallspa.org) or pop them into suggestion boxes that will be placed in the library and around the village in the next few weeks or into the parish office at 17 Stanhope Avenue.

The ideal end is a facility as unique as we have now- but smarter and more attractive, better used in quiet periods, perhaps with a longer season and needing minimal, or no, subsidy. One that is an asset not just to Woodhall Spa but to the county- and beyond. It's a balancing act, but with your help we should be able to achieve it.

**NEIGHBOURHOOD WATCH-OR NOT?** We need your help to update the Neighbourhood Watch records as many co-ordinators have moved on and we, the police and the PCSOs are anxious to know who is still doing the job out there. So please, if you are a co-ordinator, contact the clerk and tell her you're still active - as soon as possible.

**GREEN WASTE COLLECTION** will be suspended from 20<sup>th</sup> November until 2nd April as a cost cutting measure by East Lindsey District Council. The Parish council will be discussing the issue at our meeting on 3<sup>rd</sup> November.

**CEMEX LATEST-** You will be pleased to hear that following amendments to the routes of lorries going to and from the planned new quarry on Tattershall Rd, most are now to access the main A roads via Tatterhsall Thorpe, unless they need to come through the Spa for a local delivery. The Parish Council has continued to press strongly the issue of additional HGV traffic through the village. There are additional safeguards included in the latest application and we are seeking clarification on their exact meaning and legal status.

**TWINNING VISIT.** A visit to our twin village in France has been arranged for Easter next year- 9<sup>th</sup> -13<sup>th</sup> April. The group needs to know numbers as soon as possible so they can book a coach if enough want to travel that way. New families and individuals are welcome. Contact Andrew Hayden on 353142.
